# **EIMS Data Privacy Policy**

#### Who We Are

EIMS provides outsourced services to high technology vendors to help them build their businesses through effective lifecycle management of new and existing customers and channel partners.

Our headquarters are in the UK and we have operations in the U.S., Asia Pacific and mainland Europe.

EIMS is registered with the UK Information Commissioners Office (ICO) as a Data Controller (registration: ZA290698). The ICO <a href="https://ico.org.uk/">https://ico.org.uk/</a> is the UK's independent authority set up to uphold information rights in the public interest, promoting openness by public bodies and data privacy for individuals. It is the designated EU supervisory Body and regulatory authority for General Data Protection Regulation (GDPR).

#### What Information We Collect

To manage our own business we process employee, client and business partner (e.g. supplier) data. We also collect and process data on behalf of our clients relating to their customers, business partners, and target accounts in defined markets. Client data only relates to the campaigns EIMS delivers on their behalf and is restricted to the business to business market. We do not collect data relating to consumers or activities of people in a personal capacity.

We obtain business contact data (name, title, contact information [e.g. email, phone number and postal address, company name, size of business, industry, location]) from reputable agencies, public sources, our clients, and through our own research. Wherever possible originating data sources are recorded.

## Why We Need Personal Data

To manage our own business we process employee, client (existing and prospective) and supplier data to perform Human Resource Management and Payroll duties and to manage relationships, projects and billing.

On behalf of clients we manage and process personal data to perform business-to-business CLM (Customer Lifecycle Management) tasks such as Marketing, Sales, and post-sales Customer Service and support.

Unless we specify otherwise the legal grounds for our collection and processing of personal data is the Legitimate Business Interest of EIMS or our clients. We review the legitimacy of those interests on a case by case basis considering the rights and interests of individuals whose data we hold. Our clients will normally define the legal ground(s) for processing data where EIMS provides services to them as a processor. EIMS assumes obligations to protect and manage your personal data.

## What We'll Do with Your Personal Data

If we ask for your personal data, we'll make it clear why we are asking for it. For instance, we may need your email to send you something you have requested or a phone number if you have asked to be contacted.

When acting as a data controller will not provide your personal information to any third parties for the purpose of direct marketing without your express consent. When acting as processor on behalf of a client we will share your personal information with that client to the extent of our contractual and statutory obligations.

**International Data Transfers** - We may on occasion transfer data between any of the countries in which we or our clients operate in a role as either controller or to fulfil our contractual obligations as a data processor.

EIMS will not use your personal data in any automated decision-making techniques that could result in decisions that might affect you.

We may also share personal data with other organisations where there is a contractual obligation to fulfil aspects of its processing, for example payroll suppliers for our own employee benefits or service providers who manage aspects of our technical infrastructure.

### How Long Do We Need It For?

We only keep data for the period for which we see it as relevant. This would typically be for as long as the individual occupies the professional position that we have a legitimate interest in. This could be years in some cases, but our processes seek to update and refresh data to ensure that it remains accurate and relevant if held for a significant period.

Data held on behalf of clients where EIMS acts as a data processor is subject to specific client agreements and will typically be returned to the client at the end of an engagement and cease to be processed by EIMS.

#### How We Look After It?

We will take reasonable technical and organisational precautions to prevent the loss, misuse or unauthorised alteration of your personal information.

We will store any personal information you provide on our secure servers in the EU.
